Almost every study and question that our State Capitol Committee needs answered to make an informed decision on the future of Capitol Lake is now available and subject to transparent review by the informed public. We need effective government leadership to help shape a Community Plan for Our Urban Waterfront - Budd Bay; Capitol Lake and the Deschutes Urban Watershed; and from the Henderson Bridge to Priest Point Park.

Our choices are:

- 1) Natural Environments -Reconstruction of <u>all</u> tidal mudflats <u>and</u> Deconstruction of <u>all</u> man-made influences
- 2) A Managed Urban Watershed includes Capitol Lake
- 3) Stats Quo Do Nothing

DREDGING IS NEEDED NOW

Not dredged since 1986, the Lake is filling with sediment. Dredging is needed to deepen the lake and improve water quality. Capitol Lake is the Deschutes River Watershed's biggest and best asset for preventing and reducing water quality degradation in Budd Inlet.
